Membership Fees Concession in 2010

First of all, thank you very much for your support to the Association in past years.

In the Annual General Meeting on 5th May, 2009, the Board of Directors reported the Association's healthy financial situation. Some members have suggested that members may be given a membership fee concession in order to share a token of the financial success.

The Board of Directors have discussed the subject and come up with the decision that for all members who have fully paid up their annual membership fee in 2009 will enjoy one year free membership concession in 2010. Details of the concession are as follows:

- a) Members who have fully paid up their annual membership fee in 2009 will enjoy one year free membership concession in 2010;
- b) The above concession applies to corporate members as well as individual members;
- c) New members joining the Association in the first six months of the year, and who have fully paid up the annual membership fee will be entitled to the concession;
- d) New members joining the Association in the second six months of the year may elect to pay the six-month membership fee, but they would not be entitled to the concession. However, if they elect to pay the full year's membership fee, they would also be entitled to the concession.

You may wish to know that the Board of Directors has also decided to continue financing the three scholarships given out last year, as part of the contribution to the society.

You may also wish to note that the Carbon Audit Profession (CAP) course in June was a success, with 55 attendees. The Association has planned to organize another Certified Energy Manager (CEM) course in October.
