Objective

With a view to promoting the facility management profession and recognizing the excellence in performance of delivering quality service to local and overseas facilities, HKIFM is proud to present the **EXCELLENCE IN FACILITY MANAGEMENT AWARD (EFMA) 2016** to organizations and service providers of specialized sectors of the Profession.

Key Assessment Factor

1. Demonstrating exemplary records of specific recognized performance in different sectors of facility management to generate cost effective quality service;
2. Applying facility management technologies such as BIM, CMMS, ISO9001, ISO14001, ISO50001 and OHSAS 18001;
3. Implementing happy workplace culture with strong leadership for teambuilding;
4. Developing green initiatives and carbon less facility management practices;
5. Fostering clear directions for occupational health & safety ; and
6. Adopting barrier free access approach in service provision.

In general, the performance would be measured with reference to the best Energy Management practice and initiatives, appropriate and effective policies, and processes or technology that have been applied on this aspect.

1. Application/nomination documents and related materials shall be submitted to HKIFM office.
2. Site visits may be conducted to properties shortlisted by the Panel of Judges. The applicants/nominees shall have to arrange visits for judges, upon notification from the Organizing Committee.
3. Video submission may be requested for EFMA (Asia Pacific) entries, to be shortlisted by the Panel of Judges.
4. Grand Award winners shall arrange a visit/attend a symposium for sharing their experience in 2017.
