INSTRUCTIONS FOR APPLICATION FOR MEMBERSHIP

1. General

- 1.1 The application should be completed in full and must be accompanied by the following documents as appropriate:
 - Photocopy of certificates and diplomas of membership of other professional institutions
 - Photocopy of certificates and diplomas for academic qualifications
- 1.2 Any false declarations, whether on the part of the applicant or the proposer(s), may lead to disciplinary and/or legal action.
- 1.3 The Association is not bound to give any reason for their refusal to admit any person to membership, or to transfer a person from one class of membership to another. Any applicant who is refused admission shall not re-submit within 12 calendar months from the date the application is rejected.
- 1.4 Applications which do not meet the full requirements of the by-laws of the Association will not be considered. The Association reserve their rights not to consider any applications should the required information is not disclosed by the applicant.

2. Qualifications for various Classes of Membership

- 2.1 Application for the class of **Fellow**:
 - Fellow shall be a Member with significant contribution to the energy engineering industry and/or to the development of the Association and be recommended by the Board to become Fellow.
- 2.2 Application for the class of **Member**:
 - Member shall be a graduate from an engineering college or university or be a professional engineer or architect. Others with appropriate qualification and experience and approved by the Board can also be accepted as members.
- 2.3 Application for the class of **Affiliate**:
 - Affiliate Member shall be a person interested in the objectives of the Association who is not completely qualified to be a full member.



INSTRUCTIONS FOR APPLICATION FOR MEMBERSHIP (Cont'd)

- 2.4 Application for the class of **Studen**t:
 - Student Member shall be an individual under 30 years of age and be a student in a college or university preferably of technical discipline.
- 2.5 Application for the class of **Corporation (For Firms Only)**:
 - Corporation Member shall be a corporation, firm or institution actively engaged in consulting, manufacturing of energy related products or services which endorses the policies of the Association.

3. Annual Membership Fee and Corporation Admission Fee

- 3.1 All applications must be accompanied with the annual membership fee. Annual membership fee paid is not refundable. Annual membership fee will be refunded to the applicant if the application is refused.
